Representatives from stakeholders reported on any problems with local train services, including Collingham's lack of service to Newark Northgate. At present it is difficult to travel between Collingham and London without travelling between the two Newark stations, which is difficult for the less able and those with luggage. The Swinderby resignalling project, train reliability and irregular service intervals were also raised. It is very difficult to add extra services as Nottingham and Lincoln stations are at capacity and the Newark flat crossing is a bottleneck but more three-car trains are likely to help.
